Now, therefore, the J&K Housing Board, as Lessor is completely satisfied that the above Lessees to whom residential plots have been allotted in Housing Colonies, Channi Himmat, Jammu have neither raised boundaries nor taken up any construction on the plots allotted to them and thus have violated conditions of agreement. The lessees by leaving the plots vacant without construction have allowed the premises to become NUISANCE and ANNOYANCE not only to nearby residents but to the Lessor as well.

J&K Housing Board is, therefore, issuing this notice to all the above mentioned allottees, who have violated the lease deed conditions, to:

- Start covering of their vacant plots by way of construction of compound wall of standard specifications around their plots within a period of 20 days and complete the process within 60 days from the date of issuance of this notice at first instance; and
- ii. Start building construction thereafter failing which the Housing Board shall invoke relevant provisions of Lease Deed Agreement executed/registered between parties that cover imposing of penalty and even cancellation of Lease Deed.
