TECHNICAL SPECIFICATION OF ACOUSTIC ENCLOSURE

1. The enclosure is modular in construction.
2. Enclosure fabricate with 16 SWG CRC Sheet.
3. GI perforated sheet 0.4 mm thick.
4. Durable industrial locking system on doors.
5. Gas kitted doors with high quality.
6. Sound proofing with rock wool.
7. Rock wool thickness 50 mm.
8. Rock wool covering with fire proof tissue paper.
9. Acoustic enclosure is designed for the loss of 25 DB (A) at the distance of 1 m from the acoustic as per the CPCB norms. (75 DB (A) at 1 m Distance)
10. Temperature difference between ambient enclosure controlled below 7 to 10 degree centigrade.
11. Zinc passivity hardware is used to avoid rusting.
12. Canopy is fully detachable as it should work on the principal of nut and bolt.
13. Big size opening doors may make easy access for repair etc. of the full length of DG.
14. Heavy duty hinges for doors.
15. Durable Auto painting and good finishing.
16. Air intake exhaust and silencer of “ CANOPY” are designed such that leakage of sounds should not takes place.

Nature of Work: -Supply and installation of canopy (Acoustic enclosures) and all accessories .

1. The supply of canopy (Acoustic enclosures) shall be F.O.R viz J&K Housing Board Guest House Gandhi Nagar Jammu.
2. The firm/ dealer / manufacturer shall furnish all the technical details of equipment quoted by them.
3. Earnest money deposit @ 2% of total value of offered amount pledged to Financial Advisor / CAO J&K Housing Board in the shape of CDR/ FDR .
4. The tender should be addressed to Deputy General Manager, J&K Housing Unit-III Gole Market, Jammu and sent either through registered post / speed post or courier on or before the last date and time prescribed for the receipt of the tender .
5. Conditional tender such as “subject to market fluctuations” shall not be accepted .
6. The rates must be quoted in Indian currency only.
7. The tender opening authority shall not bound to accept the lowest or any other tender and reserve to himself the right of accepting the whole or any portion of any tender as it may deem fit with out assigning any reason thereof.
8. The rates offered by the tenderers must include all costs including basic cost, CST, toll taxes , entry tax , transportation to site storage at site, It shall include all service tax, sales tax, excise duty ,income tax etc.
9. No compensation for damage to equipment in transit or otherwise shall be entertained.
10. The firm /dealer/ manufacturer shall invariably supply the material within stipulated time as per the condition of NIT.
11. In case of dispute the decision of the Managing Director J&K Housing Board shall be the final and binding upon both the parties.
12. All pages of tender shall be duly signed by the tenderer under seal.
